- Double legalised notarial certified copy regarding marital status (not older than

- 6 months. May be older than 6 months as a result of the duration of the procedure.)
- Proof positive result civic integration exam (unless exempted or without obligation for civic integration exam)

## **Family reunion/stay minor with parent**

- Positive advice IND
- MVV-application form + 2 passport size photographs (when younger than 12 years, signed by parent, guardian or trustee)
- Valid passport
- Copy passport
- Copy hukou
- Double legalised notarial birth certificate
- In case applicant is child of a single father or mother or child from a previous marriage or relationship:
  - Double legalised notarial certified copy confirming legal guardianship of the parent(s);
  - In case of shared legal guardianship: written statement of approval of the parent who is staying in China;
  - Copy passport/id-card of that parent
- Copy passport/id-card of both parents/ref
- If 15 years or older: signed declaration by applicant confirming not being married and not being responsible for own child

## **Stay single parent over 65 with child**
