Please note that international students requiring an entry visa for the Netherlands should submit a verified copy of the Bachelor degree before July 1, 2013 .

The study load of the MSc programme is 120 ECTS ¹⁾ credits. This is the equivalent of two academic years. You will compose your definite study programme in consultation with your study advisor, after arrival in Wageningen. The main aspects of your study programme and the planning of the education will be laid down in a 'Study Contract' at the beginning of your study. This may imply that there are restrictions to the specialisation or track that you can follow within the programme.
